## STUDENT ACCESS TO THE WEB/INTERNET

The Web/Internet is an excellent source of data for students who may be researching information for a school project. As such, its use by students within the school is to be restricted to legitimate school and educational purposes.

Parents and students should be aware that there is an abundant amount of information available on the Web/Internet whose use would breach local, state, or federal regulations. It is the position of this school that if a student uses the Web/Internet to peruse, copy, or download such information, the student is vulnerable to accusations of unethical and unauthorized use of the information and possibly criminal charges.

The school will make every attempt to confine the Web's/Internet's use by students to legitimate purposes by providing electronic safeguards, supervision and/or configuring computers in such a manner in classrooms that the information displayed on the screen can be readily observed by the supervising teacher or volunteer.

Should there be any violation involving the ethical and legitimate use of the Web/Internet, the student will have their privileges revoked and, if appropriate, legal action may be initiated.

As the parent or guardian of the student identified below, I understand that Web/Internet access is intended for educational purposes only. I also acknowledge the difficulties in restricting access to controversial materials that may be on the network.

I agree that I will not hold **Harvest Christian School**, or its employees responsible for any claims, causes, or actions initiated by a third party as a result of my child's use, or misuse, of the school internet connection. I also agree that the school has the right to revoke my child's access to this Web/Internet connection if a violation of the spirit and intent of this agreement occurs. I have discussed the importance of using this educational tool in a responsible way with my child.
